## BID SPECIFICATIONS

1. Products must be free of impurities and registered for appropriate use in the State of Florida.
2. Citrus County Mosquito Control District will have sole and final determination of the fitness of any product and reserves the right to refuse any and all bid submission.
3. Citrus County Mosquito Control District reserves the right to purchase from an alternate source if a like product can be purchased for at least 5% less than the existing bid.
4. The District reserves the right to award a bid to multiple bidders if the bid prices are the same.
5. The bid period is up to the December 2023 Regular Board Meeting, with the option of a six month extension (June 30, 2024).
6. Bids may be extended to cover the next bidding cycle if mutually agreeable.
7. Labels and MSDS's for each product must be included with the bid submission.
8. Description of packaging; i.e: steel 275 gallon container, 2.5 gallon high density polyethylene jug, plastic bag 6 mil thick.

10. Citrus County Mosquito Control District reserves the right to require a chemical analysis to insure the product offered is per desired label standards.
